

# SETTING THE CONTEXT


The objective of this project was to document the issues and opportunities created by the region's unique geographic position, with the goal of "**Strengthening the Outaouais' competitive position with respect to its border situation**". To carry out this project, we chose to take into consideration the entire cross-border territory – including Eastern Ontario as well as the territories on the outskirts of Ottawa-Gatineau (MRCs and counties) – and to see the border situation as a distinctive advantage on which the Outaouais and Eastern Ontario should build for their economic development.


The use of the term *cross-border* in this study is not a trivial choice. This word refers to a territory that extends on both sides of the border and is characterized by the development of close ties based on openness and accessibility between the two adjacent regions, despite their differences. "The shift from border to cross-border refers to the idea that connection outweighs separation and that structured, organized, and sustainable exchanges take place over short distances on both sides of the border" (Reitel and Zander, 2004, p.2).

# DELIMITATION OF THE CROSS-BORDER TERRITORY

The study area encompasses the Outaouais administrative region (the 4 MRCs – Collines-de-l'Outaouais, Papineau, Pontiac, Vallée-de-la-Gatineau – and the City of Gatineau) and Eastern Ontario (the 3 counties of Renfrew, Lanark, Prescott-Russell and the City of Ottawa). This territory was defined on the basis of two criteria: proximity and cross-border labour mobility.

Map 1 shows the cross-border territory. In 2016, there were 1,577,272 people in this territory: 76% (1,194,668) in Eastern Ontario and 24% (382,604) in the Outaouais.

Chantale Doucet is a researcher specializing in territorial development with more than 20 years of experience in research and teaching. Her research on the multidimensional nature of the region's development (economic and social aspects, demographics, entrepreneurship, governance, agriculture, immigration, cross-border realities, education, innovation, etc.), including urban, peri-urban and rural realities, has enabled her to develop a fine knowledge of the Outaouais.



## STRENGTHENING THE COMPETITIVE POSITION OF OUTAOUAIS AND EASTERN ONTARIO

Gathering and analyzing the available data and knowledge on the issues and opportunities created by the unique border situation of the Outaouais and Eastern Ontario in various domains, mainly economic, was a major task. After all, for more than 50 years, speeches and studies on the development of the Outaouais in all its facets have always taken this regional characteristic into account. As a result, information is abundant, but scattered. This snapshot of the state of knowledge on the impacts and opportunities associated with the border context is therefore voluminous, as evidenced by the <u>24</u> sections of the report that will be available on the ODO website prior to launch.

Our presentation will take the form of a cross-sectional analysis of these results based on the following:

- The strengths and similarities that advantageously distinguish the Outaouais and Eastern Ontario from Quebec and Ontario. They are numerous, as are our complementary strengths.
- How far we have come in the last 50 years, particularly in the last few decades, with the establishment of links between several actors on both sides of the border. We will provide an overview of the main reasons that motivated these linkages in the Outaouais, but also in Eastern Ontario. This section will also set the stage for the panel of experts that will follow and provide concrete examples of cross-border collaborations and initiatives.
- The barriers and challenges that remain, many of which stem from differences in provincial legislation and regulations.
- The follow-up and next steps, as this project shows that the work to strengthen our competitive border position has already begun. We must continue this work.

This presentation is based on the <u>cross-cutting conclusion of our report</u>, which will be published on our website before the launch. This conclusion, which is still in draft form, will be enriched afterwards from the reflections we will gather during the launch and from the steering and monitoring committee that has accompanied us throughout this project. He is currently leading a Social Sciences and Humanities Research Council (SSHRC) funded research project entitled *Gouvernance métropolitaine et planification spatiale collaborative dans la région de la capitale nationale du Canada*, which focuses on interprovincial linkages for sustainable mobility and major metropolitan urban revitalization projects (2018-2023).
